7 charged in Count One: Guilty.

8 If you have found the defendant guilty on Count Two,
9 has the government proven beyond a reasonable doubt that the
10 conspiracy was to use or carry machine guns during and in
11 relation to the conspiracy charged in Count One, or to
12 knowingly possess machine guns in furtherance of the conspiracy
13 charged in Count One, and that the defendant intentionally and
14 knowingly became a member of that conspiracy? Yes.
